

Ride the Rose & Cruise the Connector

Headwaters Trails Fundraiser

WHEN: Sunday, August 26, 2007, 8 a.m. to 3:30 p.m.

WHERE: Rose Oaks County Park trails, back roads connector to Springfield Oaks County Park and Springfield Oaks County Park. The ride will be in two parts: ride the trails in Rose Oaks only or also cruise to Springfield Oaks County Park on the marked connector.

HOW: Riders will collect pledges for completing the ride. A minimum pledge of \$10 is required. Prizes, including an Oakland County Parks vehicle permit and other items, will be given to the riders collecting the most pledges.

COST: Registration fee \$10
 Daily permit (required) \$ 5 (No daily needed with 2007 Oakland County Parks vehicle permit)
 Minimum donation (in lieu of pledges) \$10

Schedule

Registration: \$10 plus sponsor fees (minimum \$10) 8 - 11 a.m.
 Ride the Rose Oaks Trails: 8:30 a.m. - 2 p.m. (Last rider out at 2 p.m.)
 Trailer parking will be available near the entrance to Rose Oaks, off Fish Lake Road.

Ride the Connector: Leave Rose Oaks between 10:45 - 11:30 a.m.

Drop off horses during registration. Be there early, then drive your rig to Springfield Oaks and park it. A shuttle will bring you back to Rose Oaks.

Shuttles will only run 9 - 11 a.m. Volunteers at Rose Oaks will watch the horses until riders return on the shuttle.

 Milford Road crossing with Oakland County Sheriff's Office assistance 11:30 a.m. - 12:45 p.m.

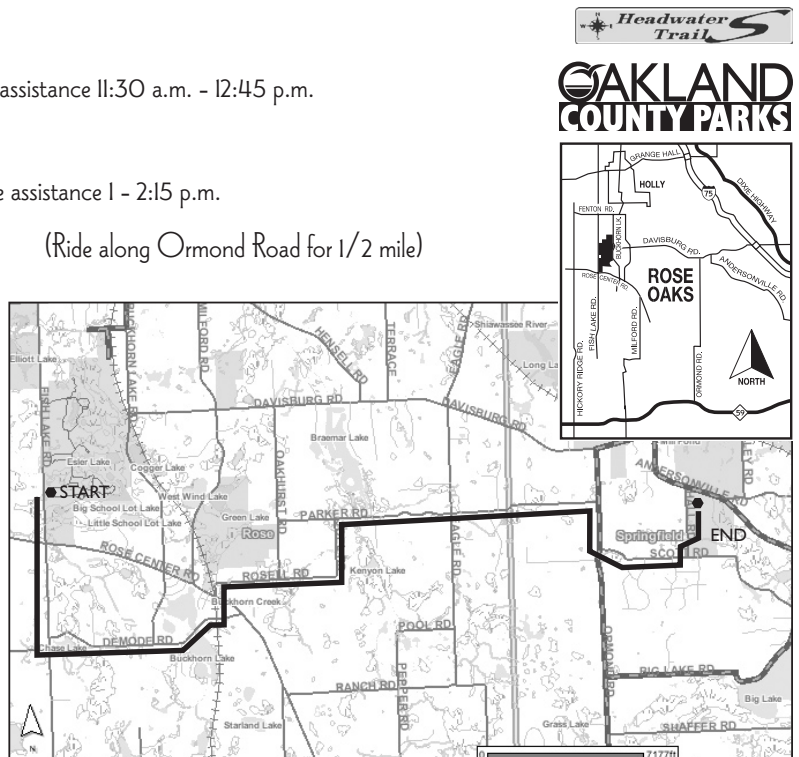
Milford Rd. to Ormond Rd. 4 miles

Ormond Road to Springfield Oaks 1.4 miles (Ride along Ormond Road for 1/2 mile)
 Total miles 8.6 miles
